## Rules and Regulations of Society

1. Name of Society : **Prahalad Rai Agrawal Education Society**
2. Head office of the Society shall be situated at Ambikapur in tahsil of the Suguja District & its address shall be 15/198 Brumh Road, Ambikapur, Surguja (C.G.)
3. Working region of the society (Jurisdiction): All over Chhattisgarh State .
4. **Objects :**

1. To Circulate and to provide Standard Higher Education and Computer Education.

2. Taking Welfare work for Society.



5. **Membership:** the society will have following kinds of members

5 (a) **Patron Member :**

- i) The first Sev6n members of the Society will be patron members.
- ii) Any eligible person may be taken as patron member, if 2/3rd of existing Patron members accept the application of such person.
- iii) Numbers of patron members should not be less than 7 or more than 21.
- iv) Any member will not remain member on acceptance of his/her resignation by YS of the existing patron members or on his/her death or being lunatic.
- v) A meeting of Patron Members will be called by Chairman or Secretary of Governing council once in three years or as and when necessary.
- vi) 25% of the existing patron Members may call the meeting giving a notice to all.

Any eligible person paying rupees 1 Lac at a time or in 12 installment within 12 months will be come a life member. they will not pay any annual fees.

b. **Ordinary Member**

Any eligible person who gives rupees. 2000/- As membership fees will become and ordinary member. Each ordinary member has to pay annual fees of Rs. 2400/- during the first quarter of each financial year of the society as renewal fees of his/her membership.

c. **Honorarium Member :**

Society may appoint eligible person as honorarium member of the society.

Honorarium member may take part in general body meeting , but they not have voting power.

d. **Obtaining Membership :**

Any person interested to become member of the society shall make a written application. The application will be placed before the governing council whose decision shall be final.

6. **Admission of members :**

7. **Qualification of Member:**

Any individual human beings having following qualities is eligible in the society.

1. He/She must be more then 18 year.
2. He / She must be citizen of India or any person who is not the citizen of any country of foreigner not declared in eligible to do the business in India by the constitution of India.
3. The person who take oath to follow rules , regulation and constitution of the society.

8. **CEASURE OF MEMBERSHIP:-**

10. **General Body Meeting :-**

- a) **Constitution:-** all member who has paid their dues are member of general body having Voting rights including ordinary member, life member.

- b) **Notice of AGM/EGM:-** If required , meeting of general body may be called by the president of the society or secretary , giving notice of minimum fifteen days to all member for date , place , time and agenda of such meeting.
- c) AGM/EGM (1) there will be an annual meeting of general body called as AGM.
- (II) Any general body meeting called for any reason during the financial year will be called, as extraordinary general body meeting know as EGM.
- iii) **QUORUM :-** -3/5th of the eligible member will constitution quorum for meeting. In case quorum is not fulfill ed then after adjournment for one hour meeting can be continued at the same place, on same date with out fulfilling the quorum.
- (d) **calling AGM/EGM:-**If one third number of eligible, member demand in writing to call for general body meeting then, such meeting will be called, by secretary or president or necessary by registrar of societies.

10(A) **General Body will have following rights(in addition to above):-**

- (I) To approved the Annual Report of the society.
- (ii) To accept Receipt and disbursement A/C of all or any institution run by the society
- (iii) To appoint Auditor for the next year.
- (iv) To approve budget for the next year.
- (v) To discuss and approved all other matter presented by governing council, or president of the society.
- (vi) General body may changed constitution of the society for which approval of 66% member of the society will be required who has to take part in discussion in general body meeting called for change in constitution of society.

11(A) **Power and duties of governing council:-**

- (i) To get and achieve the objective of the society.
- (ii) To approve the receipt and disbursement A/C annually along with the progress for AGM or EGM.



- (iii) To pay the employees of the society or of the other institution under the society and to pay taxes and duties payable on assets of the society.
- (iv) Appointment of the employees and other office bearers.
- (v) To endure that all assets of society is in the name of the society only.
- (vi) To ensure that without writing permission of the societies no fixed assets will be acquired or disbursed.
- (vii) To call an extra ordinary meeting to discuss and finalize any change in the constitution of the society, submit it to the general body where after approval the same should be sent to the registrar of the society for approval.
- (viii) To appointment of creation of committees sub comities with delegates power for smooth functioning and for achievement of object of society.

12. Power of President:-

- I) President of the society will be the president of governing Council and general body. The decision of the president shall be final & binding in cases of deliberations.
- II) President will have second voting power in case of equal votes on any matter.

12(A) Power of Vice-President:-

Vise President will act as a president In the absence of the president in any meeting or in Governing council or in general body meeting.

12(B) Secretary: -

- 1) Secretary of the society will be the secretary of governing council.
- 2) Secretary will call from time-to time governing council meeting , giving minimum 7 days notice in writing to its members.

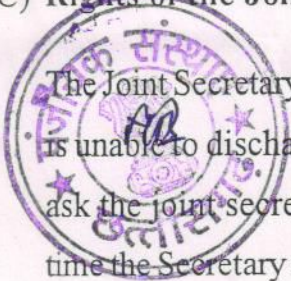

12(C) Rights of the Joint Secretary: -



The Joint Secretary shall work in the absence of the Secretary. When the Secretary is unable to discharge his duty due to absence, illness or any other cause, he may ask the joint secretary to discharge his functions and he shall do so until such time the Secretary resumes his duties. The Joint Secretary shall help the Secretary in all or any of his work and affairs as entrusted to him by the Secretary.

12(D) Power of Treasure: -

14. Information to be sent to the Registrar :-

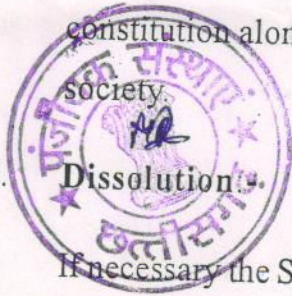
According to the Section 27 of Chhattisgarh Society Registrikaran Adhiniyam,

1973 the Society shall have to file the list of Governing Body in the prescribed form within 45 days of the date of Annual General Body Meeting and according to Section 28 of the act, Society shall have to send the Accounts along with the prescribed fees.

15. **Amendment :-**

Amendment in the constitution of the society should be approved by 2/3 members of general body and should be approved and registered by the registrar of the societies on which registrar has the right to make amendment in the constitution which will be binding to all the members. Proposal for amendment in the constitution along with the required fee will be submitted to the registrar of the



16. **Dissolution :-**

If necessary the Society may be dissolved by 3/5th majority votes of the General body members. In that case all balance property movable and immovable shall be handed over to any other organization having similar aims and objectives. The process of such dissolution shall be done as per the provisions of the act.

17. **PROPERTY :-**

1. All fixed and non-fixed assets of the society will remain in the name of the society.
2. With written permission of the registrar of the society and after depositing appropriate fees, society may acquire fixed assets by donation or by purchase.
3. Acquisition, use, purchase or giving donation or disbursement of any property of society will need approval of governing council.

18. **Bank Account :**

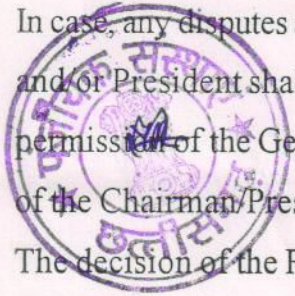
All the funds of the Society shall be parked in an account opened in a scheduled bank or post office and the process of depositing funds and withdrawal shall be go on.

19. Calling AGM by the registrar :-

If as per the registered constitution of the society annual meeting is not called by the Office bearers of the society then the registrar of the society will have right to call such meeting and to decided the agenda of the same.

20. Disputes :

In case, any disputes arises in the society or the institutions run by it, the Chairman and/or President shall have the right to resolve them within the society with due permission of the General Body. If the parties are not satisfied with the decision of the Chairman/President, he may send the case to the Registrar for settlement. The decision of the Registrar shall be final and bound to all.
