3. All employees should be trained regarding the operation of the firefighting system/equipment and their record should be maintained by regularly mock drilling for the exit points in case of disaster.
4. Building bye laws should be strictly followed while using the basement.
5. The landlord/occupant shall annually submit a declaration regarding the state of fire prevention and safety, which shall again will be worthy of inspection.
6. From the point of view of fire safety, it will be completely the responsibility of DR. RAHUL AGRAWAL to keep all the equipment installed in SADHU RAM VIDYA MANDIR running smoothly, for which the Municipal Army, Fire and Emergency Services & State Disaster Response Force Headquarters Chhattisgarh will not have any responsibility.
7. NOC is issued on the condition of increasing water resources as per the recommendation of the inspection team.




